With reference to the subject cited above, INC have resolved the following Resolution regarding Granting of Mercy Chance/ Relaxation of Maximum time period to the students who have completed the theory & clinicals for the course GNM/BSc(N) and have backlogs/failed/not attempted the final examinations.

"Maximum time limit for completing nursing course can be relaxed subject to the condition that, such candidate qualify a basic examination conducted (for the purpose) by the respective State Nursing Council in order to be allowed to continue the course/appear in the University examination".
