APNMC - INC - Mercy Chance - Revised Circular with extension of date for submission of applications till 10th May, 2024 to get aware of the candidates who require eligibility examination to continue the respective nursing course - Reg.

In continuation to the previous Circular issued by this Council (reference-3) & the Notification issued by the INC (reference-4), the following guidelines are provided for Examination in Lieu of Mercy Chance for Relaxation of Maximum Time Period - B.Sc.(N)/GNM:

As per the Indian Nursing Council Notification no. 1-5/2018-INC dated 15th March, 2019 and based on the requests received from various Students /Nursing Institutions from time to time for granting relaxation of maximum time period for the candidates who are unable to complete Nursing course in prescribed time limit (i.e. double the duration of the course); the Council defines "Grant of Mercy Chance" as under:

"Maximum time limit for completing Nursing Course can be relaxed subject to the condition that, such candidate qualify a basic examination conducted (for the purpose) by the respective State Nursing Council in order to be allowed to appear in the final year University examination." It is clarified that "Mercy chance is not applicable to candidates who discontinue or re-join the Course."

It is clarified that "Mercy Chance is not applicable to candidates who discontinue or re-join the Course". This Council will not be approached for any case to complete prescribed hours of training exceeding maximum time limit. It is therefore, Mercy Chance is applicable only for Final Year University/ Board Examination as defined above.

- 2. MAXIMUM NO. OF ATTEMPTS: 2 (Two)
- 3. ELIGIBILE CANDIDATES: Mercy Chance will only be applicable to those candidates who have completed the Nursing course (theory & practical hours) in prescribed maximum time limit (double the duration of the course) and the candidate was not able to clear the final year examinations of the respective course within the prescribed maximum duration
- 4. DURATION OF THE EXAM: 2 (Two) Hours

APNMC have received various applications from the candidates seeking to appear for the examination as a one-time measure, allowing them to continue their respective nursing courses. However, in order to accommodate all eligible candidates and ensure fairness, it is further decided to extend the last date for receiving applications until 10th May, 2024.

This extension will provide ample of time for candidates to submit their applications and to process them accordingly. This extension will help to better identify candidates who require the eligibility examination to continue their nursing education.

Hence, your cooperation is required in disseminating this information to all concerned Government & Private Nursing Institutions who offer GNM/B.Sc(N) Courses in the State of Andhra Pradesh, including candidates and relevant stakeholders. Additionally, please to ensure that all applications are submitted by the revised deadline to facilitate a smooth examination process on or before 10th May, 2024.
