Subject:- Measures to eradicate ragging in Colleges

Sir/Madam,



Hereby you are directed to enforce the following measures in curbing the ragging in your college and hostel premises:

- Assure new students that they will not be subjected to ragging.
- Hold introduction meeting with first year students as well as senior students along with concerned faculty.
- Have all anti-ragging measures in place as earlier communicated (Ref. 22-10/2015-INC (AR) dated 19/9/2017).
- Updating all details related to anti-ragging (Nodal officer, Committee details) on the college website.
- Holding seminars for first to final year students of different nursing programmes on anti-ragging.
- Arrange to have separate floor in the hostel for first year students.
- Watching movement and behavior of senior students in CCTV camera. One staff member to be dedicated exclusively for this purpose. Taking immediate action if incidents of ragging are observed.
- More security personnel to be deployed in first three month (if needed) to ensure ragging does not happen in the college/hostel premises.
- Deputing lecturer in rotation to take rounds of hostel/college so that it becomes deterrent for seniors to indulge in ragging.

- Taking prompt action on students indulging in ragging.
- Responsibility for incidents of ragging in the college/hostel is to be fixed on concerned authority of the college.
- All incidents of ragging and suggestions for eradicating ragging should be reported to the Nodal officer (Anti-ragging officer/lecturer/anti-ragging committee).
- Have an on-line system in place (Plus college phone, college e-mail) for students to report any incidents of ragging (even anonymously).
- Teachers should not make first year students to depend on the senior students for getting class notes, text-books, previous year question papers etc.
- ID card must be made compulsory for senior students inside the campus (Library, canteen, hostel, campus area) so that they are easily indentified when they indulge in ragging.
- A checklist may be prepared by college authorities to ensure that all actions are taken to prevent ragging in the college campus/hostel premises.
- Independent authorities from UGC/University/State Nursing Council may visit the
  college and check if there is compliance to the specified requirements for antiragging. College may be penalized for not complying with the specified anti-ragging
  requirements (Like CCTV camera, Anti-ragging committee, non-updation of details
  on college website etc.).
